MINUTES FOR THE REGULAR MEETING of the JENKINS TOWNSHIP BOARD OF SUPERVISORS January 11th, 2017 at 7:00PM

- 1. CALL MEETING TO ORDER

Mr. Sperrazza asked the pubic if they wished to address the Board of Supervisors regarding any items placed on the agenda for this meeting and/or any general municipal business. He asked the public who wished to address them to sign the sheet clearly with name, address and phone number. He asked that all cell phones and pagers be turned off during the meeting.

- Resident—Top of Main and Chestnut St. addressed their concerns about how it is uninhabited for many years. Many windows are broken, stairs falling down, the huge eyesore for the property for a long time that should be sited. Why isn't something being done about it. Mr. Linskey responded that we contract with the City of Pittston and Harry Smith is the code enforcement officer for 1 day per week. Owner has not responded to the violation notices that were sent. Owner is out of state. Several local municipalities are trying through the land Bank to clean blighted properties. It is hopeful that they can do this because there is a section back there with an empty lot and perhaps we can clean it up and get it sold to be back for us to get the taxes.
- They wanted answers about the township employees cutting the grass and if any one paid for that. They said we should have nothing to do with this property. Mr. Sperrazza said we are supposed to be sending them bills. JoElle Dougherty responded that she sent 3 letters and they keep coming back. The supervisors discussed this with Attorney Ross and we will make sure that they are billed and a municipal lien will be placed on the property. A resident heard the property may go up for tax or sheriffs sale. Mr. Linskey said we may have to wait until then to see about it at that time.
- Rene-Resident-Complaints regarding the area going through the tracks by Laflin Rd. considered Laflin. No tractor trailers are supposed to be allowed and now they are flying though there and blocking this area. If you go up Laflin Rd. to Main St. They Chief of Police said this is Laflin. The traffic is terrible when people are leaving Wesley Village. Mr. Sperrazza asked about what time and She said they are going through approximately 3:30-4:00 P.M. and also by Rutledge St. When she walks her dog they go through stop signs. She has pictures. Mr. Sperrazza said they are coming out from Passan Dr. and there are signs Laflin has there. Mr. Linskey asked if we could have any extra patrols there. They asked if we can have police monitor this and can a letter be sent to Wesley Village and the business owners regarding citizen's complaints. They use it as a speedway coming from Wesley Village and Highlands where the new homes are in the back. We have a lot

of people who walk their animals. Something is going to end up happening there at that stop sign.

- Bonnie Bordowski-Had questions regarding the new garbage fees, stickers and bins. They bought bags and she only goes through about 25 per year. She only needed 4 bags to get her through the end of the year. The guy in the office told her she didn't have to buy bags too but just buy a sticker but they weren't here yet? Now it is a substantial financial increase and she just bought the bags at the end of the year and has to pay the sticker fee. This is unfair. Why were we charged \$47.50 and What can be done? Mr. Linskey responded with the new fees and sizes of the bins and explained to her that they did not know what the changes were going to be at that time. They had to put it out for bid and they went with the lowest responsible bidder. At that time the guy may not have known what they changes were. The company is County Waste and they go by using the stickers and the bins. The changes were made around December 20, 2016. Hopefully the transition will go well and everything will work out fine. Mr. Linskey said we discussed if we gave residents a sheet of refuse bulk stickers for just purchasing the bags. It will be a sheet of 6 stickers for free as a compensation for how you bought bags.
- Jerry Selima-Sunrise Dr.- He heard that someone asked about a grant for \$40,000.00 for LED lights in the ballpark and inquire about grants for the Little League. Mr. Sperrazza said this is the first he has heard about this. Mr. Linskey asked Mr. LaFratte to speak about this that he heard they wanted our help to write the grants. We are not sponsoring it, he believes. Mr. LaFratte said he did not have a chance to work on it. He will start the process but there are no guarantees. This is not directed at anyone in particular but he said he contacted the township building and a public employee answered the phone and did not announce their name. When questioned in return their response was well who is this? He said when you answer a phone you should hear Jenkins Township and the name of the person who you are talking to. Mr. Linskey said this will be addresses and you will hear Jenkins Township and that person's name. He also said regarding the trash and recycling cans how will it be addressed if they are damaged or stolen? Mr. Sperrazza said they will be replaced. When will the bins be delivered. Mr. Linskey said there are a few hiccups but we have addressed them.
 - Mr. Selima questioned if we receive money for recycling and Mr. Sperrazza said yes. He asked how much but it's somewhere around \$2000.00 -\$3,000.00 plus what they pay employees hours and we do get tonnage.
- Lou Campenni-Sunrise Dr.-He picked up on W. Sunrise Dr. piles of boxes from Christmas, large black bags that the refuse truck lost bags and all over the street, in his yard and in Mike Amitia's yard was a large amount of Styrofoam. He as a resident, not an employee brought it to the township building and he said to Barbara, manager, what am I going to do with it. Mr. Jones said the landfill won't take it. Ms. Fairchild asked if she could speak and said she contacted Mr. Puerro and she had to get the company to come pick it up here. Is Styrofoam recyclable? Mr. Jones said the landfill did not want to take it for garbage. The hauler said he would take care of it. Ms. Fairchild said she would like this information the County Waste will be providing to be put on the website.
- Mr. Sperrazza asked if the Dumpsters for garbage and recycling going to be at the dump and Mr. Lewis did not know. He asked if this could be done for when something is missed and then our employees could get it and put it in the dumpsters.
- A resident asked about ashes. Mr. Sperrazza said dump them in the bin. Ms. Fairchild said she was told to explain that cold not hot ashes could be dumped over the bags of refuse and they want everything to be dumped so they are not lifting cans of ashes.
