There are several streets such as Oak, Laird, Winter, Union with water issues and isn't there any storm water funding? Why do you allow when a developer comes to Jenkins Twp. that there should be rules followed and not let them get away with such things. Well I still have a hole by the wall on Market St. This was never done right. Joe Lewis said he put a cone down there and it will be fixed. Trucks are flying on the roads and tractor trailers. Why can't we have a 15 MPH sign. She feels things are falling on deaf ears. No one is doing anything to get things done. Stan said people want the roads paved. He said it will done asap.
- Mary Ellen Vodzak-18 Spring St.-There are terrible cat issues. What is the amount of pets you can have? JoElle Dougherty said 5 cats but must be spayed or neutered. We still have the problems with catching and getting them spayed or neutered and we still work with the girls at Whiskers World.
- Cindy Romanowski-Kittens were in the garage that had litters and she wants to trap. JoElle said she will look into it.
- Louis Campenni-23 Sunrise Dr.-He said the cats are affecting their area also-across from the home that is ready to collapse, Biajody house is through PNC bank and we should have that torn down. Please address the grass. JoElle Dougherty said they are working on this also. Delregno is next door and now they have 4-5 cats that are having kittens.
