Mr. Sprerrazza suggested to have topsoil placed there to build it up. Mr. Linskey asked are you living there and how he gets his wife into the home now. Mr. Knopka said he has to take her around the back and he is fixing the home to sell it.
- Mr. Rovinski asked if anyone had concerns for a short question and answer session before we proceed with the rest of the meeting for IDC, Property. Mr. Linskey read the items from the letter of Sept. 7, 2017 from Greg Adelman. Mr. Stackhouse said the custom gate is on order and he hoped would be delivered by today and the barriers would be moved when the gate is here and keys provided to the township. We found out that the traffic light is set a certain way and we cannot change that. A stop sign was discussed to be placed near the Ice Box but may be a hazard.
