WVSA Stormwater Fee Update: Current rate projections from feasibility study estimates:

\$3.00 - \$4.50/month/ERU, or \$4.00 -\$5.50 with municipal reimbursement program. (Anticipate fee less than \$4.50 with reimbursement program)Capital Improvement Reimbursement Program-desire to set SW Fee at a level which will provide roughly \$10/year/ERU back to municipalities for Capital Improvements, A reimbursement program would be developed for municipal capital improvement expenditures, reimbursement per municipality would be up to a pre-established amount which would be impacted by delinquent accounts.50/50 cost share program also being considered. Initial reimbursements may commence around January 2019. Possible opportunity for WVSA to provide Street Sweeping Services-Municipal interest in receiving street sweeping support-response is needed.
