January 09, 2019 7:00 P.M.

Mr. Rovinski Called the Meeting to order at 7:02 P.M.

Everyone joined in the PLEDGE OF ALLEGIANCE

ROLL CALL was taken. Present were Stanley E. Rovinski – Chairman, Joseph Sperrazza - Vice Chairman, Robert Linskey-Secretary/Treasurer, Charles G. Ross Jr., Esq.-Solicitor, Barbara Fairchild - Township Manager

The floor was open to the public to address the Board of Supervisors regarding any items placed on the agenda for this meeting and/or any general municipal business. Residents were requested to sign the sheet clearly with name, address and phone number. Please remember to address the board of supervisors directly with your comments. The Board of Supervisors would ask that all cell phones and any electronic device be turned off during the meeting. Mr. Rovinski said there were many participants tonight and he wanted to address all concerns.

- 1.) James McLaughlin-280 Westminster Rd.-Questioned about the IDC agreement with WVSA. He has chemicals that come down from Owens Illinois in his back yard which are contaminated. At one time the water was a Natural Stream now it is classified as Storm water. Mr. Linskey offered to have the Senator or State Rep contacted. Mr. McLaughlin feels we are fighting a losing battle.
- 2.) Larry Rodeghiero-864 Westminster Rd.-Complaints about the WVSA Storm water bills that everyone received. Why are we getting billed and not New York or Maryland? Mr. Linskey said it is mandated. We and 31 other municipalities worked with WVSA to keep your fees lower. Mr. Rovinski said we would have to double your taxes if we took this on by ourselves. Mr. Sperrazza said if Jenkins Twp. had to do all of the items to reduce the phosphates it would cost us over \$5million, plus \$250,000 or more for operating costs. He also wanted to know if we can get something done about the Truckers and dump trucks that use Jake Brakes.
- 3.) Joe Valvonis-488 Westminster Rd. The WVSA Flyer said we would have an average bill of \$4.80/month. His is over 3 times that and he is a senior citizen living on a fixed income. What is the appeal process? 3 acres are mostly swamp. We shouldn't have to pay
- 4.) Glenys Karpovich-15 Market St.-I receive water in my basement Storm grates were covered on Main St. The water gets worse every time there is a development. It comes down the hill on Market St. We asked for a real engineer to review the way you chose to build that wall. If you knew the Storm water issue was coming, why didn't you have a public meeting and notify us the bills were coming. Mr. Rovinski said we fixed things on your street. She said how much more fees are we supposed to pay? Is there an appeal process? Mr. Linskey and Mr. Rovinski said yes. She asked how far in advance do you plan things? Mr. Linskey said we do have a comprehensive plan? Ms. Fairchild said we have one from 1966. Mr. Rovinski said he doesn't want his taxes to go up. Glenys said people are losing their homes,

- everything is going up and there should be more long range planning. Also why do we only have certain providers for internet? Can't you have another agreement for your franchise agreement other than Comcast? Something needs to be done. Mr. Linskey said we have not had a tax increase in over 5 years. She started to argue with him.
- 5.) Dave Rodeghiero-Westminster Rd. He has a wooded property and does not have sewers and feels this is not fair. He discussed the same issues. This is a false promise and scare tactics and we should have addressed this with the state. Mr. Rovinski said we were told we had to clean up the Chesepeake Bay and this is what we are doing what we were told to do.
- 6.) Mark LaVerde-4 Weidner Dr. What is going on with Wesley Village and why wasn't any educated about the expansion? They had a mess before and were fined \$25,000.00 Does anyone have calibration on this? Mr. Linskey you are on the WVSA Board what do you do about the new developments and as a Twp Supervisor you do not know about the problems and how you are to rectify things? He asked Ms. Dougherty about the advertising for Wesley Village she said it was in the media and on the news. He said here's \$100.00 that isn't true. Mr. Rovinski said it had to come before the planning and you are welcome to come to the meetings. Storm water runoff is addressed. There was a heated discussion with the supervisors.
- 7.) Paul Savakinas-853 Main St.-He verified what Mr. LeVerde said about the state pushing rocks across the road and if the information Mr. Rodeghiero said about the phosphates and everything what kind of projects are they going to do for us besides street sweeping storm basins when they are going to cover 31 municipalities. Who gets what done first? Mr. Linskey said they are doing things already. Please call PennDot to address the basins on Main St.
- 8.) Jean Mudlock-Laflin Rd.- Regarding Wesley Village they took over landscaping and are they getting non-profit? How much are they paying? The nursing home is an exempt status. They are getting an in-lieu of tax with your agreement and this should be renegotiated. Homes are paying over \$3,000.00. This is a massive operation. She received a letter from a Westminster resident from Representative Carroll. He informed them that there was no state mandate. Jenkins Twp. should have opted out and other communities like Dupont and Avoca opted out so why would Jenkins not opt out? Mr. Linskey used figures from the engineer and we made the right decision. Mr. Sperrazza said we have to do this and we looked at the state went to review all the things that had to be considered and we cannot speak for the other communities and what will happen if they chose to make their decision but they will have to do something. We cannot speak for them but can speak for our decision and what we did is more cost effective in the long run.
- 9.) Mark LeVerde also questioned what the WVSA Board members get such as a salary and medical benefits. Mr. Linskey said he is on the board and does get a small life insurance policy for about \$35-40,000.00 but he doesn't know of other perks he is getting.
