- 2.) Al DeGannaro-representing JP Mascaro-He questioned bid documents he requested. He didn't see the bid bond and asked if the board would consider hiring two separate companies for the Refuse and Recycling to be picked up. There would be a savings of \$31,000.00 if this was done.
- 3.) Simon Para-When will you be relocating the cat rescue trailers? They need to go. They didn't put the angle iron up. Mr. Rovinski said he met with FEMA and needs another meeting. Brenda is trapping them. Mr. Para said there must be about 10 running around his property now. Mr. Sperrazza said e only saw 2 yesterday.
- 4.) Ray Joplin-Laflin Rd. Presented a report for the Veteran's Memorial Committee. The fund raisers they have had and donations received have yielded a balance of \$5,244.96 in their account. They put \$3,000.00 down on the monument and have a balance of \$3,700.00. Total cost was \$6,700.00. They receive a call from Mr. Mericle and met with Bryan McManus and they are going to assist them with all of the excavation, concrete and they will still have to raise some more money to pay for the memorial. They want to have a parade and dedication of the memorial for next Memorial Day. The T-Shirts were modeled and can still be ordered.
- 5.) Ernest Harrison St. Marks Lane-He questioned if he could pave his alley. The supervisors asked Attorney Ross and he said if they wanted to allow it he said ok. The supervisors approved the paving. He also thanked the supervisors and police department that he can now access his property. The vehicles are gone finally.
- 6.) Corinne Pourmonir-1267 Main St. She recently started a food give-a-way for CEO on the first Friday every month and is requesting use of a building. The demand for space and safety on Main St. at her current location has grown and would appreciate if the Jenkins Township Fire Co. can assist or the Jenkins Twp. Supervisors.
