JENKINS TOWNSHIP DECLARATION OF DISASTER EMERGENCY

- WHEREAS, on March 6, 2020 Governor Thomas Wolf declared a "public health emergency" throughout the Commonwealth of Pennsylvania; a novel coronavirus (now known as "COVID-19") which emerged the threat of imminent disaster to the health of the citizens of the Commonwealth
- WHEREAS, the COVID-19 virus has endangered the health, safety and welfare of persons residing in Jenkins Township and threatens to create problems greater in scope than we may be able to resolve; and
- WHEREAS, The Jenkins Township Board of Supervisors held a meeting on March 16, 2020 to declare the disaster of emergency and that emergency management measures are required to reduce the severity of this disaster and to protect the health, safety and welfare of affected residents in Jenkins Township
- NOW, THEREFORE, we, the undersigned Jenkins Township Board of Supervisors, pursuant to the Provisions of Section 7301(c) of the Pennsylvania Emergency Management Services Code, (35 PA C.S., Section7101), as amended, do hereby declare the existence of a disaster emergency in Jenkins Township
- FURTHER, we direct the to coordinate the activities of the emergency response, to take all appropriate action needed to alleviate the effects of this disaster, to aid in the restoration of essential public services, and to take any other emergency response action deemed necessary to respond to this emergency.

STILL FURTHER, As Governor Wolf has urged the governing bodies and executive officers of all political subdivisions affected by this emergency to act as necessary to meet any actions taken to implement any plans coordinated through the Pennsylvania Emergency Management Agency, we authorize officials of Jenkins Township to act as necessary to meet the current exigencies of this emergency, entering into any such contracts and agreements for the performance of public work as may be required to meet the emergency, all without regard to those time-consuming procedures and formalities normally prescribed by law, mandatory constitutional requirements excepted. requirements and

This Declaration shall take effect immediately.

JENKINS TOWNSHIP EMERGENCY DECLARATION

The Jenkins Township Board of Supervisors held an Emergency Management meeting on March 16, 2020 at 9:30am.

The purpose of the meeting was to discuss the proper course of action to mitigate the spread of the COVID-19 virus amongst township residents and all employees.

In attendance were Dan Kosisky, Fire Chief, Don Sartin, Chief Engineer both from the JTFD, Joe Lewis, Jenkins Road Foreman, Capt. Emmett Thomas, Greater Pittston Regional Ambulance, Jack Lasky, Emergency Management Coordinator, Chief Frank Mudlock, JTPD, Robby Linskey, Joey Sperrazza and Stan Rovinski, Jenkins Township Board of Supervisors.

Police Chief Frank Mudlock has secured the building but the JTPD will address all calls. Any questions or requests can be made by calling the township at 570-654-3315.

The Jenkins Township Fire Dept. is on a lockdown and no visitors are allowed. All emergency calls will be answered and a protocol is in place.

Emergency Management advised people "do not panic." If you have questions; a COVID-19 virus hotline is available at 570-284-3657 staffed by Geisinger Health.

Greater Pittston Regional Ambulance is prepared and "geared up" to handle calls. Capt. Thomas advised the committee that all vehicles were disinfected and the Paramedics and EMT's are properly equipped to handle all cases safely.

Tax Collector Jean Mudlock advises residents that the township office is closed. Payments of taxes can be made by check and dropped off at her residence, 3 Laflin Road, Jenkins Township.

All township transactions will be made by phone or mail until further notice. Any questions will be answered by calling the Township building at 570-654-3315.

Joey Sperrazza, COVID-19, co-coordinator reiterates that Jenkins Township is committed to keeping all residents safe and healthy and will take every measure to prevent the spread of the virus; furthermore; if any resident needs assistance the township will assist by any means we can.
