- D. David Neeley, asked if the township pays for the street sweeping from WVSA. Mr. Rovinski stated that PennDOT contracted with WVSA to sweep the roads. He also asked about regulating the use of jake brakes in town. Chief Mudlock stated he believes the issue was addressed several years ago by PennDot. He also asked about tractor trailers illegally using Market Street. Chief Mudlock explained that trucks are using GPS and taking them to the wrong streets because of similar street names in other towns. Mr. Linskey explained that payments to storm water go into a fund which municipalities get a share of this money for storm water projects and Jenkins gets approximately \$70,000.00 dollars which is used to address storm water problems.

E. Shirley Berti Neeley, asked about truck traffic and the work that is being done on River Road and Saylor Ave. She is concerned about the increased of traffic. Mr. Rovinski explained that Mericle will have to get all the proper permits.
