

**JENKINS TOWNSHIP BOARD OF SUPERVISORS MINUTES
SPECIAL MEETING
NOVEMBER 30, 2022 – 12:00 P.M.**

Mr. Rovinski Called the Meeting to order at 12:05 P. M.

Everyone joined in the **PLEDGE OF ALLEGIANCE**

ROLL CALL was taken. Present were Stanley E. Rovinski, Chairman; Joseph Sperrazza, Vice Chairman; Robert Linskey, Secretary/Treasurer; Charles G. Ross Jr., Esquire, Solicitor.

PUBLIC PARTICIPATION- IF ANYONE WANTED TO ADDRESS ANYTHING PERTAINING TO THE AGENDA OR THE MEETING, THEY WERE INVITED TO DO SO.

- Jonas Kreitzer of GFL/County Waste questioned the Township on their intent to circumvent bidding requirements with regard to 2023 Refuse & Recycling.
- The Township explained that an emergency situation exists and they are waiving the competitive bidding requirements due to circumstances beyond their control. Such emergency presents health and safety problems and an immediate threat to the community if garbage is not collected. This is being done on a month-to-month basis until the Township acquires its own garbage truck and assumes the responsibility. The interim services will be bid out, but there is not enough time to obtain services by January 1, 2023, following the advertising requirements for bidding.
- Jonas expressed that GFL would like an opportunity to bid on an interim contract with the Township.
