**FIRST MATTER: ORDINANCE 1 OF 2025**

An Ordinance of the Board of Supervisors providing for the transfer of territory, namely, parcel numbers:

33-E11S1-013-019-000,

33-E11S1-013-020-000,

33-E11S1-001-017-000,

33-E11S1-001-016-000,

or colloquially known as the Pittston Hospital site, from Jenkins Township as authorized by Act 41 of July 7, 2022, P.L. 455, No. 41, repealing all other Ordinances and parts of Ordinances in conflict therewith.

**SECOND MATTER: ORDINANCE 2 OF 2025**

An Ordinance of the Board of Supervisors setting forth the compensation of Supervisors of Townships of the Second Class as enacted by Act 94 of 2024. Annual salary on a monthly basis.

Currently, Supervisors of Second-Class Townships receive \$1,875.00 annually for Township populations less than 4,999.

Under this Ordinance each Supervisor of Jenkins Township entering office after the effective date of this Ordinance shall receive \$3,145.00 annually, on a monthly basis, for populations less than 4,999.

Such compensation shall be paid in 8 monthly installments of \$262.08; and 4 monthly installments of \$262.09 each.
